#### 1.1.1. General politics, 1409-1703

- 1.1.1.1 Letter by the Duchess of Luxemburg and Brabant [Elisabeth van Görlitz, 1409-1415?] concerning gheleyde [toll, free-conduct?] for those of Diest. She cannot help Antwerp because the Duke, who is now abroad, made the agreement. Louvain, 6 June.
- 1.1.1.2 Copy of letters by Margaret of Burgundy and Jacoba van Beieren accepting the punishment of Willem van den Berghe, Treasurer of Brabant. The Hague, 30 September [1418].
- 1.1.1.3 Copy of a letter answering Bishop Elect of Liège John of Bavaria, who accused his niece Jacoba, [1420].
- 1.1.1.4 Letter by Mayors and Council of Zierikzee affirming that wild fellows from Zierikzee and elsewhere appropriated seized beer, saying it was stolen from subjects of the Countess in Dordrecht. They will answer for it before the Duke of Brabant in Antwerp (15<sup>th</sup> century).
- 1.1.1.5 Report on measures to evict the Lord of Wittem from Valkenburg castle, decided in a meeting of deputies of the four main cities of Brabant in Maastricht (15<sup>th</sup> century).
- 1.1.1.6 Letter by the Duke of Burgundy to Louvain, Brussels and Antwerp concerning the situation of his cousin, the Duke of Brabant [Philippe de St. Pol]. Paris, 07.11.1430.
- 1.1.1.7 Convocation by the Duke on request of Bois-le Duc to assent to letters of arrest against subjects of the Duke of Lunenburg because of seizures from their burghers, and a punishment on request of Jan van Hoerne, Lord of Puurs and Duffel (15<sup>th</sup> century).
- 1.1.1.8 Draft by deputies of the Cities of Antwerp and Brussels in Walem against a meeting of the States of Brabant because of a difference between Louvain and the Nobility (15<sup>th</sup> century).

### **1.1.3. Free access to fairs, 1382-1706**

- 1.1.3.4 Copy of a letter by the Aldermen of Douai stating that their merchants went unmolested through Brabant to the two yearly Antwerp fairs even during the wars in Flanders, [c. 1392].
- 1.1.3.5 Draft of a letter to the Count of Holland and Zeeland offering to bring all arrested subjects and ships on both sides to Yerseke. Burghers and subjects of Antwerp were arrested in violation of the peace of the fair (14<sup>th</sup> century).
- 1.1.3.6 Copy of a vidimus by Petrus Abbot of St. Bernard supra Scaldam of an order by John Duke of Burgundy dated Oudenaerde 1405.08.07 to Phil. le Josne a.o. to restore English merchandise sent to the Antwerp Whitsun fair, 1405.08.13.

- 1.1.3.15 Letter by the magistrate of Houdeng to the magistrate of Antwerp assuring that Lysbetten Thyntels, widow of Wouter van der Tenten from Brussels, will not be arrested on her return from the Antwerp fair, asking to free their citizens. Houdeng, 19.06.1469.
- 1.1.3.16 Copy of a verdict by the magistrate of Bruges between Geoffroy Blaeuwer, merchant from Calais, and Willem Slyk, freeing Blaeuwer because he was arrested within the prolongation of the Antwerp fair. Bruges, 1473.07.25.
- 1.1.3.17 Copy of a confirmation by Emperor Frederick III dated Frankfurt 8 March 1486 of a privilege by Emperor Sigismund allowing free access to the Antwerp fair.
- 1.1.3.18 Letter on behalf of Roman King Maximilian. Pieter van Winter from Bruges sent money to Cologne as payment for wine from the autumn market of Antwerp. It was seized under Sittard. Antwerp should pay him back. Bruges, [14]87.06.13.
- 1.1.3.19 Notes on violations of the peace during the Antwerp fair which were punished: near Breda in the time of Duke John; when Peter van Hoboken was sheriff, in [14]87 and in [14]89.
- 1.1.3.20 Notes to the Archduke [Maximilian] pleading against restriction of the Antwerp fair with references to Duke Charles (the Bold) and the late Emperor Frederick (III) (15<sup>th</sup> century).

- 1.1.8.25 Mayors, Aldermen and Council of Antwerp promise to repay Gerard Rantsouw and others their capital and 5% interest at the highest, but His Majesty should repay the city first.
- 1.1.8.26 Legal advice to the city of Antwerp, harassed by creditors since the central government converted the interest on remaining loans in 1571 at 6%. She can have recourse to the Reichskammergericht in Speyer. Antwerp, 1590.10.29.
- 1.1.8.27 Copy from “‘t seste boeck van gerecouvreerde stucken” what leaving citizens must pay the city, as an argument in a trial by the issuemeester contra the priest Coetsier. Antwerp, 1630.10.10.
