### History

Founded in 1900, the Labour Representation Committee changed its name into Labour Party in 1906; has its office in London.

### Content

Part of its archives, consisting of minutes of the Labour Representation Committee 1900-1906 and of the National Executive Committee of the Labour Party 1906-1967; correspondence by, and documents concerning the political activities of, the Labour Representation Committee 1900-1906, the Labour Party 1906-1916 (-1925), the War Emergency Workers' National Committee 1914-1918 and the Women's Labour League 1906-1918; minute book of the Standing Joint Committee of Industrial Women's Organisations 1916-1917.

#### Note on arrangement

Part 5 contains the first section of the subject files and is in effect a continuation of the General correspondence which appears in parts 1 and 2. When in 1907, the Labour Party radically reorganized its filing system from a chronological arrangement to a subject file system, the subject files were divided into sections, each section being called a 'volume'. Inevitably subject files have a widely disparate range of dates.
